Scholarships

We know that many students aspire to go to uni to gain a degree or go to TAFE and study towards a diploma, but for many students the costs make this unattainable. Higher education isn't free, it costs \$20,000-\$45,000 to complete a Bachelor degree and, if you have to live on campus, the fees are on average \$20,000 a year. And that's before you buy any textbooks, study materials, or IT equipment!

Scholarships exist to increase opportunities for someone just like you to access higher education. Being awarded a scholarship could mean the difference between accepting or turning down a place at university.

There are scholarships specifically tailored to the needs of regional students, and even though you might not think you are eligible, no matter what your situation or background, there is a scholarship that you can apply for.

Examples of types of scholarships include:

- Access for regional and rural students
- Residential scholarships
- Travel and study grants
- Placement grants
- Areas of study, such as agriculture, the health professions and teaching
- Scholarships for people from diverse backgrounds.

In case you are thinking you won't have a chance, let's address some common myths about scholarship success. Many people think that to get a scholarship:

- You need to be academic.
- The odds are against you because so many apply, and you don't have a hope.
- You have to be good at writing essays.

None of these are true. It is true that you will not get a scholarship unless you apply for one!

It is also true that your chances of success depend on finding the right scholarship to suit your circumstances and needs.

There are a number of key steps to follow to enhance your chances of success:

- 1.Commit: Decide that you want to apply for a scholarship
- 2. Assess: Find scholarships that you are eligible for
- 3.Research: Look far and wide
- 4. Knowledge: Know your audience/know what they are looking for
- 5. Awareness: Pay attention to your competition
- 6. Quality: Proofread everything!
- 7.Determination: Perseverance furthers! If at first you don't succeed apply again, and again...

Timing: When Do You Apply?

It is important to take note of the opening and closing dates for the scholarship you are applying for - different scholarships will have different timelines to adhere to. Make sure you allow plenty of time to prepare your application and to collect any additional information or documents that may be required.

QTAC Scholarship Applications: What Are They?

Many Queensland universities use the QTAC platform to process scholarship applications, particularly for students applying to study for the first time. There are various types of scholarships you can apply for through QTAC, including:

- Financial disadvantage
- Academic achievement
- Being the first in your immediate family to attend university
- Being an Indigenous Australian
- Being a refugee or asylum seeker
- Having to relocate to attend tertiary study
- Intending to live on campus
- Having been in formal out-of-home care
- Having a disability or medical condition that affects your education
- Having experienced difficult circumstances that have affected your education
- Community service
- Leadership

How To Apply via QTAC:

- 1. Scholarship application deadlines can vary depending on the institution and specific scholarship. It's essential to regularly check the QTAC website and the websites of the universities you're interested in for the most up-to-date information on application opening dates and deadlines. - 2.Go to the QTAC website <u>www.qtac.edu.au</u>
- 3.Create an account with QTAC or log in to the one you have already created using your QTAC Application Number & PIN.
- 4.Select 'Scholarship Application' in your QTAC user account (all applications are submitted online).
- 5. Enter all your personal details & provide additional information if required.

Far North Queensland Youth Assistance Fund (FNQYAF)

The Far North Queensland Youth Assistance Fund (FNQYAF) provides financial assistance to individuals under 24 years old. Scholarships of up to \$5,000 are available to support young people in pursuing educational, artistic, or sporting goals. This fund is open to youth whose parents or legal guardians reside in Far North Queensland, from Cardwell in the south, west to the Queensland border, and north to Cape York.

Eligibility:

- Must be under 24 years old
- Must reside in Far North Queensland (Cardwell to Cape York, including the western border)
- Must be pursuing educational, training, or artistic/sporting activities
- Must demonstrate need for financial assistance

Scholarship Amount: Up to \$5,000 Application Period: Annually

Cape York Leaders Program (CYLP)

The Cape York Leaders Program offers secondary and tertiary scholarships for talented Indigenous students from Cape York. The program's goal is to support students in achieving their potential and accessing quality education, along with providing mentorship and leadership development. Scholarships are available for both secondary and tertiary students and provide significant support, including access to top educational institutions across Australia.

Eligibility:

- Must be of Aboriginal and/or Torres Strait Islander descent
- Must be from the Cape York region
- Must be a secondary or tertiary student
- Must demonstrate leadership potential and a commitment to education

Scholarship Benefits:

- Access to leading educational institutions
- Ongoing support and mentorship throughout studies
- Leadership development

Scholarship Offers:

- Citizenship: Applicants must be Australian citizens or permanent residents.

- Course Enrollment: Applicants must be enrolled in an undergraduate course at CQUniversity.

Application Process:

- Application Periods: Applications for Term 1, 2025 Bursaries will open on the Census date, 1st April 2025. Term 2, 2025 Scholarship Applications are expected to open in early May 2025.
- Application Requirements: Applicants must submit a 500-word personal statement addressing how a CQUniversity scholarship will assist with their studies. The application form relevant to your scholarship of interest is found in the "Apply Now" section of the scholarship page.
- Selection Process: Applications are assessed based on eligibility criteria and the quality of the personal statement.

Tertiary Access Payment (TAP)

The Tertiary Access Payment (TAP) is a one-off payment of up to \$5,000. It's to help eligible students with the cost of moving to study. To get the payment you need to meet some rules.

These include:

- moving from a regional or remote area for tertiary study that's at least 90 minutes away from your family home location by public transport. You can check if your family home is in a regional or remote area using the <u>Student Regional Area</u> <u>Search</u>.
- starting tertiary study in the year after finishing year 12 or equivalent.
- an Australian resident
- studying a tertiary course at certificate IV or above in the 12 months immediately after completing year 12
- 22 or younger on the day you start your tertiary course
- study at least 75% of a full-time study load
- study a course with a minimum duration of one academic year.
- meet the delivery method of your study progam e.g. face-to-face, multi-modal and at a Regional University Study Hub (including as an online student).
- have parents or guardians whose income is under the current combined parental income limit of \$250,000.

You can claim this payment in your first year of tertiary study only.

Relocation Scholarship

You might get a Relocation Scholarship if you're a student getting Youth Allowance or ABSTUDY and you meet these rules:

- are a dependent student or an independent student for a special reason
- study in a specific place
- meet the study rules
- get at least \$1 of Youth Allowance as a student or ABSTUDY Living Allowance.

Student Start-up Loan

The Student Start-up Loan is a voluntary \$1,273 loan for eligible students who get Youth Allowance, Austudy or ABSTUDY Living Allowance. You can get the loan up to 2 times a year, once each loan period. Loans are tax free, and you don't need to declare them to us as income for your regular student payment.

You have to pay back the loan once you start earning a certain amount of income. You should think about how this will impact you in the long term before you apply

Rural Pharmacy Scholarship

The Rural Pharmacy Scholarship Scheme provides support to those students living in remote and rural areas. The scholarship gives the opportunity for students to complete undergraduate or postgraduate studies and are then encouraged to seek employment in rural and remote areas following graduation.

Eligibility:

- You must be an Australian citizen.
- You need to be enrolled or accepted for enrolment in an Australian university as a full-time student and be studying an undergraduate or graduate degree that leads to a registrable qualification as a Pharmacist.
- You have lived in a rural or remote area for at least five consecutive years or eight years total since the age of five.
- You need to be a member of (or be intending to join) your university's student Rural Health Club and be able to prove evidence of enrolment.

Australian Rotary Health provides scholarships for Rural Nursing, Rural Medicine, and Indigenous Health.

Indigenous Health Scholarship - These yearly scholarships are awarded to Indigenous tertiary students as a way to support the barriers of tertiary study and qualification in Australian Indigenous populations. Each scholarship is worth \$5,000 per year.

Rural Medical Scholarships - ARH uses its rural medical scholarship program to create incentive for students to undertake at least one year of work placement in rural Australian communities. Each annual scholarship is worth \$5,000.

Rural Nursing Scholarships - ARH uses its rural nursing scholarship programs to create incentive for students to undertake their final year of clinical placement in rural Australian communities. Each annual scholarship is worth \$12,500.

Commonwealth Teaching Scholarships support new undergraduate and postgraduate teaching students to meet the costs of their study in exchange for teaching in government schools or government-run early learning settings for a period of time after graduating from their degree.

Scholarships of up to \$40,000 per student are available for full-time undergraduate initial teacher education (ITE) students (\$10,000 per year for a four-year qualification) and up to \$20,000 for full-time postgraduate ITE students (\$10,000 per year for a two-year- qualification).

Applications are strongly encouraged from school leavers and career changers who meet the eligibility criteria and who are high-achieving students (with an ATAR of 80 or above or equivalent academic result), First Nations peoples, people for whom English is an additional language or dialect, people with disability, people from regional, rural or remote locations, mid-career professionals or people from low socio-economic backgrounds, who aspire to a rewarding career in teaching.

Eligibility:

- and individual located in Australia
- an Australian Citizen
- a permanent resident
- a holder of a humanitarian visa
- a New Zealand citizen living in Australia
- intend to enrol, or be enrolled, for full-time study in an accredited ITE program commencing in the first study period or semester of 2024
- not have commenced an accredited ITE program prior to the year the scholarship will be offered.
- be willing to commit to teaching for four years (undergraduate) or two years (postgraduate) in government schools or government-run early learning settings.

Scholarships will be available over five rounds from 2024 to 2028 with up to 1,000 scholarships per year to be offered. Please note, applications for round 2 have closed. To receive key dates and information about the program you can register for updates.

Additional Information:

- Concurrent Scholarships: If you apply for a Commonwealth Teaching Scholarship, you can also apply for other scholarships or incentive programs. However, you must check that there are no restrictions and that you can meet the requirements of all programs.
- Support for Diverse Applicants: Applications are strongly encouraged from school leavers, career changers, First Nations peoples, individuals for whom English is an additional language or dialect, people with disabilities, mid-career professionals, individuals from regional, rural, or remote locations, and those from low socio-economic backgrounds.
